Wow! we are starting a new year and thankful that 2020 will be in our rearview mirror. It was a challenging year for all of us, and particularly for your board of directors who conferred and attended webinars to make the best decisions on behalf of Rainberry Bay's residents. Not easy but our aim was to keep our residents (including us!) safe – I think, all in all, we did a pretty good job.

It's the time of year to recognize all the volunteers who give tirelessly throughout the year. Thank you to those that have worked with the board this past year and to those that will step up this coming year. The election for the new board will happen in March and will be followed by asking residents to step up to work on the committees.

By the time of publication, Rainberry Bay should be receiving replies from the road

contractors who are interested in bidding on our roads project. They will be submitting questions and each contractor will receive those answers. After that we expect bids and the board will be making the decision on awarding the contract and arranging for the loan. Then the logistics of which roads to close and work on during each phase.

The board recently sent out a set of Master Documents – these consist of our Declarations, By-Laws and Articles of Incorporation. (Villas Declarations and By-Laws were mailed out also.) Please take the time to look them over and please vote. The board spent more than one year working on this project, beginning back in May of 2019! (And some of you thought the roads project took a long time!) We first chose an attorney and began reviewing the original Docs to determine what needed updating. The Articles of Incorporation really needed no change, other than updating the officers. The

By-Laws required updates, requiring us to be more specific on the rules/statutes with regards to voting, among other items. We are certainly hoping they pass but please send along any questions you have and they will be answered as quickly as we can.

We need you to vote and approve these. The original Documents, from 1979, are outdated. There are a few options for voting for both Master and Villas: for those who had it mailed you can use "snail mail" or drop the ballot in the big red box by the clubhouse entrance. If you received a paper copy, keep it. No other set will be sent out.

If you opted for E-Voting you can just vote on your computer, smartphone or iPad. Easy and done!



MEET YOUR NEIGHBOR: Phyllis Berke

TERRY BARBERIO & CAMILLE PISCIOTTA



This is a love story. Terry and Camille are one of the most endearing couples I have ever met. When they first met, Camille had just groomed Terry's dog, Reggie, in her pet shop. A friend of Terry had been taking care of Reggie for months at a time and would regularly bring the dog in to be groomed. So, one fateful day, when Terry returned from out of town she went to pick Reggie up at the pet shop. Camille wasn't sure that Terry was Reggie's owner and she wouldn't release him. Well, it could have been a Shakespearean play the way Camille finally figured out that Reggie, the dog, actually belonged to Terry, an honest woman.

Anyhow, Terry fell for Camille's beautiful blue eyes, "which could take you into her soul," and for her caring personality. Camille immediately realized that Terry was, in her words, "dog people." The two of them hit it off because of their love of pets. After thirty-seven years together, they continue to be compatible and are still right for each other. Maybe it's because they each lived interesting lives and shared their experiences.

Terry worked for a mid-level accounting firm as an office manager/bookkeeper. Her favorite part of the job was acting as a kind of personal assistant to entertainers and latenight television hosts whose names she cannot mention. She said, "They are so rich

that they just wanted someone to pay their bills and send them checks for pocket money." She was on call twenty-four hours a day. If something like a client's TV set broke down, Terry would arrange for a repair man to take care of it. the Pampered Poodle Palace in Astoria, Queens. She has done everything from selling puppies to breeding, grooming and teaching others how to groom. She didn't think of herself as a groomer. She considered herself to be a pet stylist.

Camille learned some animal first-aid after working for a veterinarian for two years. On one occasion at Pampered Poodle Paradise during a grooming, a Maltese pup passed out in the bathtub. Camille was able to massage his heart and apply mouth-to-mouth resuscitation. He survived and lived on. Another time, Camille advised an owner that her cat was very pale. The owner said she didn't notice anything but was persuaded to take her cat to a vet. The vet saved the cat's life by applying dialysis in time. The owner was very grateful.

Camille's customers were very appreciative of the way she cared for their pets. She didn't place the pets in cages



The Submission, by Amy Waldman Presented by Linda MacNeal, January 7, 2021.




Linda MacNeal's book is "The Submission", by Amy Waldman.

"Our plants are doing great!"

"Plants doing fine. I just moved them to front of house (southern exposure/all day sun) and appreciative of all of the effort you all put into the class. Thanks a lot!!"

"All three of my plants: basil, cherry tomato and better boy tomato are just taking off with many little blooms. Must get a stake for support. I forgot about that."

"My plants are doing great. Tomatoes have yellow flowers. I would love another class. Perhaps ground covers."

- ☐ UNDER WHAT CONDITIONS, IF ANY, SHOULD WE COVER PLANTS OVERNIGHT, I.E. HOW CLOSE TO A FREEZE?
 - A. If the temperature is going to be at freezing, or very cold, you can bring the plant inside or you can cover it. Make sure the day before the cold temperature, water the plant deeply. Once the plant has plenty of water, it has the best chance to stay warmer as water holds the heat. Always water deep before a freeze. Of course, if you can move it inside, that is good. Plants in the ground must stay outside.
- ☐ HOW SOON TO START TAKING BASIL?
 - A. You may start to take basil any time there is basil. Don't pick off every leaf, as leaves are needed to carry sunlight into the plant.
- ☐ HOW SOON CAN I EXPECT TO SEE TOMATO FLOWERS GROWING?
 - A. Any day now. You will probably not see any bugs any time soon. Just look at your plants at least once a day to see if something is eating them for dinner.
- AT THIS TIME OF YEAR, DOES IT MATTER WHAT TIME WE WATER? I AM NOT AN EARLY BIRD, AND THINK THAT 3-4 MIGHT BE LATE FOR COOLER NIGHTS. ADVICE WELCOME.
 - A. You can water the plants anytime. Best to water at the same time everyday or water once daily, best is first thing in the morning or mid-to-late afternoon. Don't get water onto the leaves. Only water the base of the plant as far out as the branches extend. When it is very hot outside, one must be careful when watering during the heat of the day. Three or four PM is not too late to water plants. Just don't put water on the leaves.
- ☐ WHAT CAN BE PLANTED DURING WINTER MONTHS AND SURVIVE?
 - A. All plants can be planted during the winter months and survive. Now is the best season for planting.

RETHINK how you can reduce your environmental footprint.

REDUCE the amount you waste by using less.

REUSE items in good condition by donating, sharing or repurposing.

RECYCLE all acceptable items in the blue or yellow bins.

COMPOSTING EDUCATION

Composting breaks down organic matter thereby recycling nutrients to return them to the earth, so you can use the end product to improve the quality of your soil by simply using as a mulch around any plants. More composting benefits: diverts organic matter from landfills and water ways, helps reduce methane and carbon emissions; increases carbon in the soil, keeping carbon out of the atmosphere; saves water to promote healthy soil; saves you money - less need to purchase fertilizer.

GUIDELINES FOR BACKYARD COMPOSTING

The most important decision is where will you put this earth friendly tool? It should be on a convenient, level, well drained soil or a concrete area. But, more importantly, CONSIDER YOUR NEIGHBORS! Your bin cannot be seen from the street or from your neighbor's property. You must keep the area tidy and deal with odors right away (most often caused by too many Greens). In order to prevent too many Greens, you need to have enough carbon (Browns) on hand. Neighbors can help you with this by supplying you with their recycled papers and cardboard!

Another consideration when making the compost decision, is what to do with your outdoor bin during a hurricane warning.

BACKYARD COMPOSTING BASICS

All composting requires three basic ingredients:

- Browns (carbon): includes dead leaves, straw or hay, shredded paper and cardboard, pine needles, dead palm branches and leaves, dryer lint
- 2. *Greens* (nitrogen): includes veggie and fruit scraps, coffee grounds, egg shells,tea bags

RETHINK CORNER


In the United States, we use more than 50 billion plastic water bottles each year – and 38 billion of those end up in our landfills, oceans, parks and streets. It takes up to seven bottles of water and 15 gallons of oil to produce the plastic needed for one. Water bottles usually are made with BPA which are harmful to humans brains and, for those that have one, prostates. These bottles take hundreds of years to biodegrade, harming our planet and wildlife.

Try buying a reusable bpa free bottle and start substituting it for a plastic bottle. Think about buying a large container for storing water during hurricanes. It's cheaper and safer.

WORK ORDERS

Are you familiar with the Rainberry Bay work order process?

It's fairly simple. If you have an issue you can either call the office during regular business hours (easiest option) or go to the FSR private website to put in your work order (more below).

This information is given to residents by both the Block Captain's Welcome Committee and the Sales & Rentals Committee during interviews. However, some may not have used this process since the paper workorders were discontinued.

The office will take your information and advise you if the item you are reporting is your responsibility or that of the HOA's. If it is the responsibility of the HOA, someone will input your work order and make sure it is directed to the appropriate group: maintenance, roofing, landscaping, pest control, etc. Contrary to what some of us have been told, the HOA does not do everything. Also, some things, like tree trimming, are done only seasonally.

To input a work order on your computer, go to myrainberrybay.com and then log into the correct association in the FSR, private, website. (This is located in the upper right corner – look for your association: Homes or Villas.) You need to be in Homes or Villas, not Master to input the work order. In the middle of the page, you will see "Service Requests." Click here and input your request. That is also funneled to the correct group to handle the issue.

Sometimes it takes more than one work order, unfortunately, but again, not every item is covered by the HOA. If you have questions, call the office during regular office hours (Monday – Friday $8:30 \, \text{am} - 4:30 \, \text{pm}$, 561-272-6560).

You can drop off any items yourself during these hours.

The center is very organized, making it an easy way for proper disposal of hazardous waste. DIRECTIONS: East on Linton Blvd., right on SW 4th Ave, go about 1 block and turn left into site. Stay to right (you do not need to weigh in) and follow road. Please help by recycling correctly at home and disposing of hazardous items properly. Pollution prevention starts at home.

Following is a partial list of acceptable Hazardous Waste

Material: used oil, filters and antifreeze; pesticides; gas cylinders; fuel and gas containers (do not need to be emptied); flares; mercury and fluorescent lights; electronics; aerosols cans; household rechargeable batteries (alkaline batteries can be thrown away with household garbage); auto batteries; paint; used cooking oil. SHARPS ARE NOT ACCEPTED! Call 561-681-5900 for info on sharp disposal.

CLEVER & USEFUL TOOTHPASTE HACKS

CLEAN YOUR HEADLIGHTS

Hazy film on your car's headlights? Just squeeze a bit of toothpaste onto a rag, then rub the paste all over your headlights. The toothpaste will cut through the grime and leave them looking much clearer! Follow up by buffing them clean with a dry cloth.

REMOVE PERMANENT MARKER

Apply a bit of toothpaste to the accidental mark, then use a damp cloth to rub the paste into the stain. Then rinse the cloth clean and wipe up the toothpaste. This trick works on walls and wood floors.

KEEP A MIRROR FOG-FREE

Just squeeze a bit of toothpaste onto the mirror and rub it thoroughly over the glass. Then rinse the glass well to remove the excess toothpaste, and you're done!

LIGHTEN DISCOLORED FINGERNAILS

If nail polish has left your fingernails looking a bit discolored apply a small dab of whitening toothpaste to your nail, then use a nail brush or a toothbrush to give it a good scrub. Wash your hands to remove the toothpaste, and repeat daily until your fingernails return to their original color.

ERASE COFFEE STAINS

Just rub toothpaste onto the stubborn coffee and tea stains with a damp sponge. After the stains disappear, just wash the mug with soapy water and it'll be good as new!

HANG A FRAME

Use toothpaste to help mark where you want to hang a frame. Start by applying a dab of toothpaste to the hanger on the back of your frame. Then press the frame against the wall



where you want to hang it, and the toothpaste will leave a mark on the wall where the nail should go!

SHINE A SINK

Squeeze a bit of toothpaste onto a damp sponge and rub it over the surface of your stainless-steel sinks and fixtures. Rinse clean with water, and stand back to admire the shine!

FILL NAIL HOLES

Have small nail and pushpin holes in your walls? No problem, just grab your toothpaste! Squeeze a small amount of toothpaste into the hole, then wipe up any excess paste with a damp rag. It's a quick and easy fix!

 Water: most of the time you do not need to add water because greens provide enough

A healthy compost pile should have 1/3 Greens and 2/3 Brown material and should not have a bad smell. Do not add dairy, diseased or insect ridden plants, meat or fish. If you are a beginner, add a bit more Browns at first

HOW TO CHOOSE AN OUTDOOR COMPOST BIN SUITABLE FOR SMALL AREAS

Enclosed tumblers are the best option - they take up very little outdoor space, cannot be accessed by rodents or other critters, keeps compost neatly enclosed and odor free and are easy to turn. A few daily spins should mix and aerate. A dual chamber tumbler is recommended because you can

let one side mature as you add waste to the other side. They are readily available and start around \$100.

There are many resources online for home composting. The University of Florida, IFAS extension, is a good place to start. Green Committee members who already compost are pleased to answer any questions. Call Karen (217-714-2342) or Vinnie (330-256-5822). We do know of many more residents recycling and regenerating their Green and Brown materials for healthy flowers, shrubs, and vegetables.

In the December Beacon, we gave information on indoor food recyclers and Let It Rot. Next month is more on vermacomposting!

Ah, 2019 us. We were so young(ish), so innocent, so unfamiliar with the pandemic to come and all the weird, newfangled slang and terminology that would accompany it. In the time since COVID-19 swept the globe and inalterably changed our lives, we've collectively been introduced to phrases and words that would have confused the hell out of us in 2019. *Covidiot?* This is a put-down that could only come from 2020. From a recent article in HuffPost come these definitions of at least 12 words and phrases we have added to our vocabulary over the last year. In most cases, we'd be glad to never hear about them again.

FLATTENING THE CURVE:

Like the incessant "just say no" antidrug messaging in the Reagan era, we were all inundated with pleas from public officials to "flatten the curve" at the beginning of the pandemic. The curve, we soon learned, was simply the number of people who contract COVID-19, the disease caused by the coronavirus, over a period of time. Luckily, many a graphic designer sprang into action and created visuals to explain how flattening the curve works.

COMMUNITY SPREAD:

When public health experts talk about a rise in "community spread," they're saying that so many people have been infected by the virus in an area, it's hard to pinpoint where someone caught it.

ZOOM:

Prior to March 2020, if you thought of the word "zoom" at all, you might have recalled the '70's-era kids, PBS TV show, "Zoom." Zoom is widely recognized as the video conferencing platform so many of us use to communicate with friends and coworkers for happy hours and meetings. It was kind of fun at first who doesn't like to quietly judge their coworkers' apartments and homes? - but now it's the only way we can "see" familiar faces. (Most of us also wish we had invested in Zoom prior to the pandemic; we'd probably be making Oprah-size money right now if we had.)

DOOMSCROLLING:

This year gave us a lot with which to mentally grapple: a global pandemic; civil unrest over racial inequality and police violence; a high-stakes presidential election that felt like it lasted a decade. We should have taken a mental break from our phones and often unplugged. Instead, we spent most of our nights "doomscrolling"— in other words, endlessly checking social media and reading lots and lots of bad news.

MEGXIT:

Way back in the salad days of January 2020 (feels like decades ago), Prince Harry and Meghan Markle, the Duke and Duchess of Sussex announced they were leaving their positions as senior members of the royal family. (Now they're living in the states and cashing in on those royal titles with Spotify and Netflix deals.) Somewhat pithily, the British press deemed their departure "Megxit," a play on Brexit.

QUARANTINE FATIGUE:

In 2019, quarantine itself was a fairly foreign concept. After 10 months of social distancing, we're all too familiar with it. Most of us have felt quarantine fatigue at least a dozen times by now, but we muddle through. That said, some people continue to act as though we're not living through a global pandemic and go about their daily lives. Which brings us to ...

COVIDIOTS:

Macmillan Dictionary defines covidiot as "an insulting term for someone who ignores health advice about Covid-19, hoards food unnecessarily, etc." Think anti-maskers who protest in large groups. (COVID loves to see it!) Or people who insist on carrying on with their big, blowout wedding plans because, "Guys, it's my wedding day!"

QUARANTINI:

A cocktail that you drink while in

quarantine (when a person stays in a particular place for a period of time so that they don't spread or catch a disease), made from whatever ingredients are available to you

HERD IMMUNITY:

Not to be confused with "herd mentality"- what our outgoing president called it back in September -herd immunity is when enough of a population becomes immune to a disease, either because they've been vaccinated or because they've had the disease, recovered and developed immunity. When we reach herd immunity, it's unlikely COVID-19 could spread significantly, even if a small proportion of the population is still vulnerable to catching the virus. (We've seen this happen in the past with illnesses like polio and chicken pox.) Dr. Anthony Fauci, the nation's top infectious disease specialist, recently said that he predicts herd immunity for U.S. by late spring or early summer.

SUPER-SPREADER EVENT:

Super-spreader events occur when a person with COVID-19 passes the virus onto 10 or more people because of close contact and/or poor ventilation in an enclosed space. So far, super-spreader events have included weddings, nightclubs and bars, meatpacking plants, prisons — and White House celebration parties with nary a mask in sight.

PANDEMIC POD (OR SOCIAL BUBBLES):

To socialize safely, many of us formed pandemic bubbles — small groups of family and/or friends who agree to avoid close, indoor contact with anyone else but the defined itty-bitty group.

BIKE HELMET TECHNOLOGY

(FROM CONSUMER'S REPORTS: JULY 10, 2018)

Bike helmets are designed and tested for their ability to protect against severe head injury, such as a skull fracture. One newer offering in helmet technology is the Multi-directional Impact Protection System (MIPS). This thin, low-friction liner inside the helmet allows the outer shell to slide a few millimeters across the skull on impact, reducing rotational force and the amount of energy transferred to the head. Rotational force is thought to be a factor in concussions.

In our earlier tests of two pairs of the same brand and model helmets—one MIPS, one not—the MIPS helmets reduced rotational force up to 43 percent compared with the non-MIPs helmets. The MIPS helmets cost around \$20 more than non-MIPS versions of the same model.

It's difficult to prove that any helmet will protect against concussion because concussions are diagnosed based on symptoms and the results of a neurological exam; there's no single objective test, such as a CT scan or an MRI, that can determine whether someone has a concussion. That's part of why it's not possible to say for certain that MIPS helmets can reduce the chances of a concussion. But our tests suggest that there may be some added benefit, so even if it's not definitive, a MIPS helmet may be worth the extra cost.
